**RELEASE OF LIABILITY**

I acknowledge that horses (and other animals) are unpredictable, and that horseback riding and related activities carry inherent risks of injury or death or damage to myself, my minor children, my animal(s) and property. I knowingly assume all risks, whether known or unknown, of horseback riding and all related activities.

I acknowledge and understand that there are no emergency services on site at Honey Lake Valley Riders events, (ambulance, E.M.T., veterinary, etc.)

I hereby release Honey Lake Valley Riders, Inc., its directors, officers, agents, employees, instructors, clinicians, members, representatives, heirs, executors and assigns, (hereinafter collectively referred to as HLVR), and any and all owners, lessors, renters, caretakers, (where events are held), and their directors, officers, agents, employees, representatives, heirs, executors and assigns, (hereinafter collectively referred to as Property Owners), from all liability for any act of negligence or want of ordinary care on the part of HLVR and/or Property Owners. In consideration of my participation in events organized or sponsored by HLVR I waive, release and discharge HLVR and/or Property Owners from any and all claims of liability for injury, illness, or death or damage to myself, my minor children, my animals or my property arising out of my participation. This agreement is binding upon my executors, heirs and assigns.

I expressly waive any rights I may have under California Civil Code 1542, which states: "A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him might have materially affected his settlement with the debtor."

I agree that I will indemnify and hold harmless HLVR and/or Property Owners against all claims, demands, and causes of action, including court costs and actual attorney fees, arising from any proceeding or lawsuit brought by or prosecuted for my benefit, in which this release is upheld.

HLVR and/or Property Owners shall not be liable for any damages which may accrue from any cause or as a result of fire, theft, out of control animal, state of health, injury or damage to or death of person, horse, other animal, or property.
